

INVERSINE™ Advanced Universal Sinewave Filter Warranty and Performance Guarantee

1. **Warranty:** MIRUS International Inc. (MIRUS) warrants to the end-user (the Customer) of the INVERSINE™ Advanced Universal Sinewave Filter (AUSF) as follows:
 - (a) The INVERSINE™ AUSF will be free from defects in materials and workmanship under normal use and service for a period of three (3) years from the date of shipment; and
 - (b) The INVERSINE™ AUSF will perform as advertised to convert an inverter PWM output pulsed DC voltage to a near AC sinewave voltage. A properly selected and installed INVERSINE™ will:
 - (i) Improve Voltage Total Harmonic Distortion (VTHD), measured at the INVERSINE™ output terminals, to < 5%. This includes the inverter carrier frequency and all harmonics up to the 100th. However, if there are higher levels of lower frequency harmonics (i.e. 5th and 7th) than is normally generated by a PWM inverter, these will not be significantly attenuated and the residual level of VTHD could be higher than 5%.
 - (ii) Reduce dV/dT to acceptable levels and eliminate the negative effects of reflected wave phenomenon.
 - (iii) Not resonate with capacitive and inductive elements of downstream cables and motor.
 - (iv) If equipped with optional Coordinated Surge Protection (CSP), full INVERSINE™ product warranty is extended to five (5) years under the same terms and conditions stated herein.
2. **Limitation:** The foregoing warranties shall not apply and shall be void if the INVERSINE™ AUSF has been subject to misuse, abuse, accident, disaster, or has been operated contrary to MIRUS' instructions relating to installation, maintenance, use or operation.
3. **Exclusive Remedy:** If the INVERSINE™ AUSF does not conform with the warranties set out above, the Customer must notify MIRUS of the defective unit within the applicable warranty period and obtain a written return material authorization (an "RMA") from MIRUS. The Customer must return the defective unit to MIRUS, freight prepaid, within sixty (60) days of receipt of the RMA and must include a copy of MIRUS' paid invoice for the defective unit and a description of the defective unit's failure to conform. If MIRUS agrees that the returned unit is defective, MIRUS' entire obligation and liability shall be, in MIRUS' sole discretion, to repair or replace the defective unit or give a full refund of the purchase price to the Customer.

THE FOREGOING IS THE CUSTOMER'S SOLE AND EXCLUSIVE REMEDY FOR BREACH OF WARRANTY BY MIRUS WITH RESPECT TO THE INVERSINE™ AUSF.
4. **Replacement or Repaired Product Warranty:** Any repaired or replaced INVERSINE™ AUSF shall be warranted as set forth herein for the remainder of the applicable warranty period of the original unit or for three (3) months, whichever is greater.
